Upon final payment by the client, the client has limited copyright ownership of the resulting images Which may be used only for personal use and may not be copied ,or reprinted without express permission of BRIAN HURSEY Photography. The Client must obtain written permission from, and compensate BRIAN HURSEY Photography prior to the CLIENT, or its friends/ relatives publishing or selling the images for profit.
